## 2011 – 2012 CURLING MEMBERSHIP APPLICATION FORM

### TERMS OF RELEASE, INDEMNITY, AND PRIVACY CLAUSE

**Release:** In consideration of the acceptance of this application by Tam Heather Curling & Tennis Club ("Tam Heather"), I hereby release the Tam Heather Curling & Tennis Club and each of its members, officers and employees (collectively the "Releasees") from all claims for damages which I, my family and guests may have for anything done or omitted to be done as a result of negligence or otherwise in connection with the operation of Tam Heather (the "Released Claims").

**Indemnity:** In the event that any of the Released Claims are not effectively barred by the aforesaid release, for the same consideration I hereby agree to indemnify and save harmless each of the Releasees from all Released Claims which may be brought against them and from all costs and expenses, including legal costs, resulting from the making of a Released Claim. In addition, I agree to save harmless and to indemnify the Releasees for any and all damage or loss caused by me, my family or my guests.

**Privacy Clause:** Personal information collected from our members will be used in order to reach you to discuss the status of your membership with the Club, Club roster and/or by the sections in which you participate. We must also provide this information to the Ontario Curling Association when OCA fees are paid.

### CURLING MEMBERSHIP SEASON - October 1, 2011 to April 30, 2012

All memberships must be paid as per Fee Schedule prior to the start of the season.

It is the member's responsibility to inform the Club of any changes in future membership status.

### MEMBERSHIP FEE

Your Membership Fee includes the use of the club facilities.

All fees are subject to 13% HST.

Cheques must be payable to **Tam Heather Curling & Tennis Club**

### SPARE RULES

Any curler participating in daytime curling only must buy a spare card in the office if they wish to spare during the evening or weekend.

### MEN'S AND MIXED SOCIAL FEE

There is a compulsory fee for Men and Regular Mixed League players and will be in addition to membership fees as follows:

**Men** - \$10.00 social fee per season, per member, to supplement league prize expenses.

**Mixed** - \$10.00 social fee per season, per member, to cover fun night expenses.

### MINIMUM CONSUMPTION OBLIGATION (FOOD and/or BAR)

Food and Beverage accumulative total - October 1, 2011 to April 30, 2012

First time new members are exempted for the first full year of membership.

Intermediate members are exempted.

\$120.00 - All Adult Daytime only and Sunday Sinners curling member, **not payable** with application.

\$240.00 - All other Adult curling members, **not payable** with application.

**OR** \$50.00 + HST Assessment fee **payable** with application.

### LOCKERS

Annual: Full = \$37.50 + HST    Half = \$27.50 + HST

Members who have lockers are billed automatically. The office will supply locks for all lockers.

It is your responsibility to inform the office if you want to cancel your locker.

### MEMBER ACCOUNTS

Statements are to be picked up at the office during the winter season.

Payment is due at the end of each month.

### CATEGORIES

Adult: 30 years of age as of July 1, 2011

Intermediate (Students only), must submit proof of enrollment: 20 to 29 years of age as of July 1, 2011.

Couple: Two adult members living at the same address and using one main account number.
