TERMS OF RELEASE, INDEMNITY, AND PRIVACY CLAUSE

Release: In consideration of the acceptance of this application by Tam Heather Curling & Tennis Club ("Tam Heather"), I hereby release the Tam Heather Curling & Tennis Club and each of its members, officers and employees (collectively the "Releasees") from all claims for damages which I, my family and guests may have for anything done or omitted to be done as a result of negligence or otherwise in connection with the operation of Tam Heather (the "Released Claims").

Indemnity: In the event that any of the Released Claims are not effectively barred by the aforesaid release, for the same consideration I hereby agree to indemnify and save harmless each of the Releasees from all Released Claims which may be brought against them and from all costs and expenses, including legal costs, resulting from the making of a Released Claim. In addition, I agree to save harmless and to indemnify the Releasees for any and all damage or loss caused by me, my family or my guests.

Privacy Clause: Personal information collected from our members will be used in order to reach you to discuss the status of your membership with the Club, Club roster and/or by the sections in which you participate. We must also provide this information to the Scarborough Tennis Federation when requested.

PAYMENT DUE

Annual Memberships must be paid in full by **May 15, 2010**.

Summer Memberships must be paid in full by **May 15, 2010**.

Winter Memberships must be paid in full by **August 15, 2010**.

It is the member's responsibility to inform the office of any change in membership status.

MEMBERSHIP FEE

Your Membership Fee includes the use of club facilities but not court fees, unless included in membership category.

MINIMUM CONSUMPTION OBLIGATION (FOOD and/or BAR) - ANNUAL & WINTER MEMBERS

First time new members are exempted for the first year of membership.

3 Month Winter members are exempt.

\$120.00 - All Adult Winter Daytime tennis members, **not payable** with application.

\$240.00 - All other Winter or Annual Adult tennis members, **not payable** with application.

OR \$50.00 + HST Assessment fee payable with application.

Food and Beverage accumulative total – May 1, 2010 to April 30, 2011

LOCKERS (Application available in the office)

Annual fee: Full = \$37.50 + HST Half = \$27.50 + HST

Members who have lockers are billed automatically on December 1st.

It is your responsibility to inform the office if you want to cancel your locker.

COURT FEES

Summer: Court fees do **not** apply.

Winter: Early bird - \$ 9.00+ HST per hour - Mon - Sun, 7 am - 9 am.

Non-prime - \$11.00 + HST per hour - Mon - Fri, 9 am - 7 pm, Sat & Sun, 7 pm - 11 pm.

Prime time - \$14.50 + HST per hour - Mon - Fri, 7 pm - 11 pm, Sat & Sun, 9 am - 7 pm.

Block Booking: Winter Season only (Application available in the office).

Statements will be sent by mail to members during the summer season. All overdue accounts are subject to 2% per month penalty charge.

This application will not be processed if your account is in arrears.
